Sample scripts for calling NYS legislators regarding Jeff Dinowitz's bill (A-8378) to mandate COVID19 shots for all children

- Remember: be polite, respectful, but clear with your message. Do NOT harass, threaten, or use rude language.
- Make the script your own. This is just a *suggestion* on talking points.

OPTION #1

IF YOU ARE CALLING <u>YOUR</u> SPECIFIC REPRESENTATIVE:

I'm reaching out today because I want <u>(insert name of assemblyman or senator)</u> to know that I strongly oppose the bill that Assemblyman Jeff Dinowitz has proposed. That is bill # A8378, and it would require all children in NYS to get the COVID19 shot in order to attend school.

I know this bill is still just in the Health Committee, and has not yet been proposed to the full Assembly or to the Senate, but it doesn't matter. A bill such as that should never have been proposed anywhere to begin with.
